The Resident al Services Housing Contract ("Contract") establishes an agreement between Northwestern University ("University") and the student ("Student") for use of assigned space and facilities of a residence for and in consideration of the keeping and performing by Student of all understandings, agreements, terms and conditions of obligation enumerated herein.

The Contract does not guarantee assignment to a part cular type of accommodat on (room or apartment) or assignment to any preference indicated by Student. Student's preferences are requests only; preferences for room or apartment type, building of occupancy, and University's grant ng of roommate requests cannot be guaranteed. The Contract does not determine final admission of the Student to the University. Assignment to on-campus housing is cont ngent upon the University's final acceptance of the Student for admission, approval of the Contract by the Assistant Vice President of Resident al Services ("Assistant Vice President") or their designee and receipt of full payment. If the rate for space, as assigned, varies from the payment made, an addit onal charge or refund, as the case may be, will be made to the Student. I understand that unless formally released from this contract by the Assistant Vice President (see Housing Cancellat on page), I am responsible for the room rental

charges and any applicable fees.

- 2.0 MEAL PLAN: I understand that I am not required, as a condit on of living in on-campus student housing, to purchase an on-campus board (meal) plan. An opt onal board (meal) plan is available for purchase. Addit onal informat on on the opt onal board (meal) plan is available at www.dining.northwestern.edu or (847) 491-2020.
- 3.0 STUDENT STATUS: I understand that to be eligible for residence, I must be enrolled at Northwestern Un r c a roommates/suitemates must approve of guests. I further agree that I will not unreasonably interfere with my roommates' or any other resident's rights under similar residence hall contract.
- 4.0 BUSINESS USE: I understand that I may not use my residence hall room or any University housing facilities for commercial or business purposes. This includes, but is not limited to, use of phone, assigned bedspace or coluit any commercial business.

- 7.0 PAYMENTS: I agree that payment for each quarter is due in advance, in accordance with the University's <u>payment</u> <u>due dates</u>. I understand that refunds of any payments made under this Contract are subject to prorated nightly fees and a \$300 cancellat on fee.

- 18.0 COURSE REGISTRATION. Unt I all sums due and owing under this contract are fully paid, I understand that I may not register for future course work in the University or receive transcripts, diplomas or degrees.
- 19.0 CONTRACT ENFORCEABILITY. Should any part of this Contract be held invalid or unenforceable or contrary to law, that port on will be construed consistent with applicable law and the remaining port ons will remain in full force and e ect.
- 20.0 CONTRACT CANCELLATION. Any residents not bound by the terms of the two-year residency requirement (i.e. rising undergraduate third year, rising undergraduate fourth year, and graduate students) may request to cancel their housing contract for reasons outlined on the <u>Northwestern Resident al Services website</u>. Submit ng a cancellat on request is not an automat c release from your contract, nor does it guarantee that you will be released from your housing contract. Each release request is reviewed on a case-by-case basis. If approved you may be more responsible for a cancellat on fee and part/all of the contracted rate. part/all of the contracted rate.
